WAIVER AND GENERAL RELEASE
OF CLAIMS AND COVENANT NOT TO SUE

I, the undersigned, as parent or legal guardian of _____ (the "Child") hereby acknowledge that as a participant in the Chevrolet Junior Pride Crew (the "Event") at U.S. Cellular Field on _____ (date) (or any date to which rescheduled date), I and the Child assume all risk and danger incidental to the Child's participation in the Event, whether occurring prior to, during, or subsequent to the Event. I recognize and acknowledge that the Child's participation in the Event is a hazardous activity and that attendance at and participation in the Event involves a risk of personal injury to the Child and others, including the possibility of death. Nevertheless, I voluntarily elect to allow the Child to participate in the Event with knowledge of the danger involved and hereby voluntarily assume and accept any and all risks of injury or death to the Child or to any other person which may result from the Child's participation in the Event, regardless of how such injury or death may arise, and regardless of who is at fault or negligent.

I understand and agree that by signing this Waiver and General Release of Claims and Covenant Not to Sue I am releasing and discharging Chicago White Sox, Ltd., Chisox Corporation, Illinois Sports Facilities Authority, At Your Service LLC, At Your Service Management Corp., CWS Maintenance Company, Roclab Athletic Instruction LLC, Jerry Reinsdorf, Jerry M. Reinsdorf Revocable Trust, and each of their respective officers, directors, employees, agents, owners, members, partners, representatives and attorneys, and any and all of their respective subsidiaries or affiliates (the "Releasees"), from any and all claims, demands or causes of action which hereinafter may accrue against them and which in any way arise as a result of the Child's participation in the Event, regardless of whether based on fault or negligence or not. I hereby further agree to indemnify, defend and hold the Releasees harmless from and against any and all losses, damages, costs or expenses (including reasonable attorneys' fees and other costs of defense) any of which Releasees may sustain as a result of, or in connection with the Child's participation in the Event.

The Chicago White Sox and any person authorized by the Chicago White Sox are hereby granted the unrestricted right and license to use the image or likeness of the Child in any manner, including in connection with any broadcast, telecast, photograph, video or other transmissions or reproductions of the Event.

I have read this Waiver and General Release of Claims and Covenant Not to Sue carefully and fully understand its contents. I am aware that this is an agreement not to sue the Releasees and constitutes a complete release of liability by me in favor of the Releasees. I acknowledge that I am signing this document of my own free will, with full knowledge of the risks that I am assuming which include, without limitation, the risk of injury or death regardless of how it arises, even if it results from the neglect or fault of the Releasees and I hereby agree to all of its terms.
